

# IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER La Caleta Estates (TX2330063), Val Verde County, TX

LA CALETA ESTATES PWS 2330063 has violated the monitoring and reporting requirements set by Texas Commission on Environmental Quality (TCEQ) in Chapter 30, Section 290, Subchapter F. Even though these were not emergencies, as our customers, you have the right to know what happened and what we are doing (or did) to correct these situations.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During: (52): 3YR2020, we did not monitor or test for LCR and therefore cannot be sure of the quality of your drinking water during that time.



## We are taking the following actions to address this issue:

In order to return to compliance, we collected a complete set of sample tap samples from registered sites with TCEQ sent the results to TCEQ and have been in compliance since 10/09/2021.

# IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER La Caleta Estates (TX2330063), Val Verde County, TX Lead Treatment Technique Requirements Not Met, Violation Noted on Oct 17, 2024

Our water system recently violated a drinking water requirement. Although this incident was not an emergency, as our customers, you have a right to know what happened and what we did (are doing) to correct this situation.

Failure to meet minimum treatment requirements for lead has the potential to increase your exposure to lead. We did not complete the following requirement(s):

Requirement(s) not met: Submittal of the Lead Service Line Inventory (LSLI)

Period(s) of Non-Compliance: 10/16/2024 - 1/13/2025

There is no safe level of lead in drinking water. Exposure to lead in drinking water can cause serious health effects in all age groups, especially pregnant people, infants (both formula-fed and breastfed), and young children. Some of the health effects to infants and children include decreases in IQ and attention span. Lead exposure can also result in new or worsened learning and behavior problems. The children of persons who are exposed to lead before or during pregnancy may be at increased risk of these harmful health effects. Adults have increased risks of heart disease, high blood pressure, kidney or nervous system problems. Contact your health care provider for more information about your risks.

#### What should I do?

There is nothing you need to do at this time. You may continue to drink the water. We will notify you within 24 hours if a situation arises where the water is no longer safe to drink.

### What is being done?

CSWR – Texas Utility Operating Company (UOC) acquired this facility in February 2025. We have completed the Lead Service Line Inventory (LSLI) and assessed whether any service lines contain lead, galvanized steel, or unknown materials. No lead service lines have been identified thus far; however, some lines are classified as having unknown materials. We are actively working to verify these unknown service lines throughout the distribution system. At this time, there are no health concerns related to the missed reporting.
